Participant & Guardian Agreement

By signing this form, I confirm that:

- ✓ My child is within the required age limits (3-9 years) to participate in the activity.
- ✓ I understand that this activity carries inherent risks.
- ✓ My child is fully capable of taking part, and I will ensure they understand all safety information provided by Woburn Safari Park.
- ✓ I will share any relevant information with the activity instructor to enhance my child's experience.
- ✓ My child does not have any condition that may pose a risk to themselves or others.
- ✓ I do not have any conditions that would prevent me from actively and safely supervising my child(ren) during the activity.
- ✓ I acknowledge that participation may be affected by wet or adverse weather conditions, and I will ensure my child wears suitable footwear for safety.

Supervision & Responsibility

- ⦿ I understand that I must be present alongside my child(ren) at all times during the activity.
- ⦿ I accept full responsibility for supervising my child(ren) and ensuring they use the vehicles safely and follow all provided safety guidelines.
- ⦿ Activity staff will patrol the circuit, but I acknowledge that I am responsible for the safe operation of the vehicle my child(ren) is using.

◆ As the supervising adult, I will receive a remote control to control the vehicle, which must be used to stop the vehicle when necessary to prevent collisions and ensure safety.

◆ I will return the remote control along with the vehicle at the end of the session and will take due care of the remote control during use.

◆ Activity staff have a master remote control to stop all vehicles if required.

◆ I will remain attentive and aware of my surroundings and other participants throughout the activity.
